

RESOLUTION NO. 2016-079

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHINO, CALIFORNIA, APPROVING AND ADOPTING AN UPDATED COMPREHENSIVE SCHEDULE OF FEES FOR VARIOUS ANIMAL CONTROL AND HUMANE SERVICES PROVIDED BY THE INLAND VALLEY HUMANE SOCIETY (RESCINDING AND REPLACING RESOLUTION NO. 2011-33)

WHEREAS, the City of Chino is required by State mandate to provide animal care, control, and humane services for the City; and

WHEREAS, the City has, for the past several years, contracted with the Inland Valley Humane Society to provide these State mandated animal care, control, and humane services for the City; and

WHEREAS, such services consist of dog licensing, animal impounding, food and care for impounded animals, and other services as directed; and

WHEREAS, the City Council of the City of Chino has deemed it appropriate for pet owners to assist in offsetting the costs of providing these State mandated animal care, control, and humane services; and

WHEREAS, other jurisdictions that utilize the services of Inland Valley Humane Society charge fees to pet owners to help offset the costs of providing these State mandated animal care, control, and humane services; and

WHEREAS, the Inland Valley Humane Society recommends to jurisdictions a fee schedule which they believe is fair and reasonable; and

WHEREAS, the City Council is desirous of adjusting the rates currently charged for animal care, control, and humane services, to help offset a portion of the costs of providing such services; and

WHEREAS, Chino Municipal Code Chapters 6.04 and 6.08 establish that the fees related to animal care, control, and humane services shall be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF CHINO, CALIFORNIA, hereby adopts animal control service fees set forth in Exhibit "A" making them effective January 1, 2017.
